

Mississippi Timber Price Report

2nd Quarter 2019 July 3, 2019



The Mississippi Timber Price Report provides a picture of timber market activity showing regional and statewide stumpage prices for common forest products. This report should only be used as a guide to help individuals monitor timber market trends. The average price should not be applied as fair market value for a specific timber sale because many variables influence actual prices each landowner will receive. How are prices obtained? This report used data from 79 timber sales conducted and reported across Mississippi during 2nd quarter 2019. Reporters include forest product companies, logging contractors, consulting foresters, landowners, and other natural resource professionals.

Price Trends

The 2nd quarter statewide stumpage prices for pine products are in Table 1 while hardwood products are in Table 2. We have included low and high prices to indicate differences landowners could expect to receive. Graphs reflect 10-year statewide average price trends.

As expected, prices in the 2nd quarter declined as we experienced drier weather conditions and more supply was available for harvesting. The oversupply issue is still another major factor in our relatively low stumpage prices along with a weak or stagnant housing market. Additionally, international demand for our forest products, among other commodities, are feeling the impacts of tariffs. Hopefully, agreements will be reached soon and demand will begin to increase shortly thereafter. Future housing starts are projected to remain relatively flat which will continue to impact prices for an extended period. Mill expansions are expected and will provide additional market capacity in those areas. Unfortunately, the closing of the Georgia-Pacific paper mill in Port Hudson, Louisiana will hurt landowners in across southern Mississippi.

Compared to 1st quarter 2019, statewide average prices decreased for most species and product classes. Regional prices fluctuated between product classes with some experiencing substantial decreases while others had minor increases. North Mississippi prices continue to be less than south Mississippi prices primarily because of fewer mills north of Interstate 20. Expect to see prices across the state decrease as drier weather returns this quarter. Pulpwood prices, particularly in southwest Mississippi, will continue to decrease because of the paper mill closing.






Figure 2: Average Mississippi pine and hardwood pulpwood stumpage prices (\$/ton) for 2nd quarter 2009 through 2nd quarter 2019.*
