2019 Harvest of Forest Products¹ Forest Economics

February 2020

The Mississippi forest industry harvested and delivered almost \$1.2 billion worth of forest products to mills and other processors in 2019. The forest industry in Mississippi and the harvest volumes in this report include all producers and harvesters of forest products paying a timber severance tax collected by the Mississippi Department of Revenue. The total estimated value of the 2019 Mississippi timber harvest delivered to the point of first processing (such as a pulpwood yard or sawmill) was \$1,195,761,566. The estimated volume and value by product are presented in Table 1. The 2019 harvest value is 5.9% higher than the 2018 value of \$1.13 billion. This increase is related to increases in harvest volumes for every category except hardwood pulpwood, poles, and crossties (Table 2). A comparison of 2019 and 2018 Mississippi timber product prices is presented in Table 3.

Timber remains the second most valuable agricultural commodity in Mississippi for 2019. Mississippi's forest landowners collected \$645 million for their standing timber in 2019, an increase of 29% from 2018. The estimated value of the harvesting and transportation sector², which is the difference between the delivered and standing values, was \$550 million. The 2019 value of the harvesting and transportation sector accounted for 46% of the total harvest value as compared to 56% of the total harvest in 2018.

Severance tax collections on forest products were \$3,773,656 in 2019. Twenty percent of severance tax collections, or about \$754,731, is returned to counties where the timber was harvested. Eighty percent, or about \$3,018,925, is allocated to the Forest Resource Development Program (FRDP) to provide cost share funds to nonindustrial private forest landowners for reforestation and other forest management activities.

A comparison between 2019 and 2018 harvest volumes and delivered values by product category is presented in Table 2. The harvest volume of pine sawtimber increased 4% and value increased almost 5%. The volume of hardwood sawtimber increased 3% and value increased almost 6%. Pine pulpwood volume increased by almost 6% and value increased over 11% while hardwood pulpwood volume decreased by 14% with an associated value decrease of 4%. Pine pole harvest decreased by 16% in volume and 17% in value. Crosstie volume saw a decrease of 25% and value decreased by 21%. The volume of pine in-woods chips increased by 34% over 2018 volumes with an associated increase in value of 47%. Hardwood chips increased by 40% of volume and value nearly doubled.

The demand for pine sawtimber increased somewhat in 2019. U.S. housing starts in December of 2019 (an indicator of new home construction tracked by the U.S. Census Bureau) were up 16%, to 1.6 million units, reaching a 13 year high. Delivered prices of pine sawtimber remained steady reflecting the

abundance of standing volume in the state. The demand for hardwood sawtimber showed a modest increase in 2019. The volume harvested was up 3% over 2018. The crosstie harvest volume dropped almost 26%.

Demand for pine pulpwood increased 5.6% in 2019 and the delivered price increased just over 5%. Hardwood pulpwood demand dropped by almost 14% reflecting the reduction caused by the closure of the Port Hudson, LA paper mill. This sector will likely continue to decline during the next few years.

Harvested volumes by product and by county obtained from the Mississippi Department of Revenue are presented in Table 4.
